- 1. Complete the online Rebate Program Application
- 2.Upload a clear photo of your original receipt
- 3.Upload 2 photos of your new, verified, installed appliance
- 4. Allow up to 10 business days for a response to your rebate application.
- 5. You will receive an email letter for approval/denial of your rebate application.

*Incomplete applications will not be considered.



TERMS & CONDITIONS

 Must be a City of Turlock customer account. Rebate will be issued in the form of a credit to the utility account within 30 days from rebate approval.
Address of installation must be located within Turlock City limits.
Renters must have written consent from property owner prior to installation of appliance and attached to rebate application.
Rebates are available on a first

come first serve basis until program funding has been depleted.

5. Rebates may not exceed the cost of the new fixture.

6. A maximum of 3 rebates per household allowed.

7. Pre-owned and leased appliances are not eligible for program.

8. Participants may be subject to an on-site inspection performed by City personnel.

Appliance must be installed within
days of purchase.

10. Applicant must upload a photo of the original receipt of purchase and 2 photos (see photo requirements on page 2 of rebate application) of the appliance after installation.
