



2014 Five-Year Rate Plan and Recommended Five-Year Rate Plan


- Water rate increases for 2014 2019 were adopted as part of a Five-Year Rate Plan
- Groundwater only rate schedule was adopted in the 2014 Five-Year Rate Plan, surface water rates were evaluated but NOT adopted
- First four rate increases implemented July 1, 2014, January 1, 2015, January 1, 2016 and January 1, 2017
- First increase of the 2018 2022 Five-Year Rate Plan is scheduled for March 1, 2018




FY14 – FY27 Water Use




Cash Flow, DSC and Monthly Bills



Monthly Bills from Adopted Five-Year Rate Plan, 2014 Rate Study, and Current Review




FY15 – FY27 Average Monthly Water Bills

- Mail information to every property owner (or customer if renter pays the utility bill)
- Hold a hearing no less than 45 days after the mailing
- Reject the proposed water rates if written protests from a majority of the affected property owners / customers
