**Item No. 3:**

Revise paragraph directly above "Package 1 – Sewer Replacement" section on Page 69 to read as follows:

The Contractor shall complete the Sewer Improvements (Package 1) prior to starting work on the Street Improvements (Package 2); however, the Contractor may complete the concrete work in Package 2 located within existing and already acquired new right-of-way concurrently with Package 1. ***Contractor shall first trench and install the new sewer, wyes, and laterals on the south side of Wayside Drive. Upon completion of the new sewer, contractor shall remove the existing sewer and connect the laterals on the north side of Wayside Drive.***

(a) If the amount set forth as unit price is unreadable or otherwise unclear, or is omitted, or is the same as the amount as the entry in the item total column, then the amount set forth in the item total column for the item shall prevail and shall be divided by the estimated quantity for the item and the price thus obtained shall be the unit price;

(b) (Decimal Errors) If the product of the entered unit price and the estimated quantity is exactly off by a factor of ten, one hundred, etc., or one-tenth, or one-hundredth, etc. from the entered total, the discrepancy will be resolved by using the entered unit price or item total, whichever most closely approximates percentage wise the unit price or item total in the Department's Final Estimate of cost.
