**Item No. 1:**

Section 10 Construction Details

10.01 SCOPE OF WORK:

1. Removal and disposal of all interior partitions (4 total).
2. Install **an aluminum flat trim** cover on the West wall after existing tracks are removed.
3. Furnish and ~~install 3080 single swing entrance doors with panic off set, 10" bottom kick plate and overhead concealed closer to meet ADA compliance~~ **install bronze anodized medium stile out swing doors, ADA 105HO concealed closer, gear hinge, AR8800 panic hardware, 10" kick panel to meet ADA compliance. Complete frame and bronze threshold** for the North, South, and East walls.
4. Furnish and install sliding window wall system; OBE 2000 series, Class 1, bronze anodized **frame with 10" ADA kick panel on all panels** with 1/4" tempered glass.
5. Install window package (stated in 2 and 3) consisting of single swing entrance door and sliding wall system to be ~~mulled~~ **mulled** together into 1 opening in field by glazing contractor.
6. As per requirements, 1/4" clear tempered glass to be used.
7. Use configuration "~~XXXXXXO~~" "**OXX/XXX,**" **two (2) left sliders stacking behind stationary panel, three (3) right sliders stacking behind swing door on stack off track** for the North, South, and East walls.
8. All ADA doors are to be keyed alike.
9. Refer to Appendix A for additional technical requirements. All product information provided in these Special Provisions and Appendix A shall be as listed, or approved equal.
