We had a fairly busy shift for it being a Saturday evening. We ended up taking nine report calls for the shift. We made two arrests during the shift and both of the subjects were booked. SUPERVISOR COMMENTS

Most of the night was normal for a Saturday night with regard to calls for service. Numerous calls were being reported and some of which were being reported as inprogress. Most of the evening night shift officers were busy handling calls and responding to in-progress calls for service. As the night progressed the amount of pending calls decreased to only one or two calls pending, just prior to 2:00 a.m. Shortly after 2:00 a.m. that quickly changed. Within approximately 5 minutes Turlock Police Department received two in-progress calls that required multiple officers to respond to each one. The first incident was reported to be occurring in 500 block of Vermont Avenue. We received multiple calls reporting a large disturbance and one caller reported a firearm was involved. While multiple units were responding to this incident; Turlock Police Department received a call reporting a subject shot in the 100 Block of S. First St. This second incident required units to deviate from the previous call and respond to the 100 Block of S. First St. Due to the severity of both calls for service, officers had to contend with handling both critical incidents simultaneously.

The incident occurring in the area of the 500 Block of Vermont was later determined to not involve a firearm and handled by responding officers.

Officers responding to the 100 Block of S. First St. located a male subject who sustained a gunshot wound as a result of a shooting. At the time of this entry Officers and Detectives are currently investigating this incident.
