SUPERVISOR COMMENTS

Busy shift throughout the entire night. Officers investigated an aggravated assault in the 1700 Block of N. Olive where a male struck his mother with an object causing injury. The male was booked for aggravated assault related charges. Officers contacted a female suspect involved in a hit and run from another jurisdiction. After the collision was investigated the female was arrested by TPD and booked into jail for a violent crimes warrant. Officers contacted a female in the 1000 Block of Julian. She was arrested on a warrant and found to be in possession of narcotics. She was booked into jail. Officers contacted a subject called in by the reporting party in the 600 Block of N. Golden State. The subject was determined to be under the influence of narcotics and alcohol being unable to care for himself in public. He was arrested and booked into jail. Officers investigated a disturbance in the 800 Block of Shawnan. The suspect had assaulted and stolen property from his elderly mother. He subsequently used her credit cards at various establishments. He was located later in the shift driving a vehicle. After the stop was initiated, he continued to drive a short distance, parked and refused to exit the vehicle. After about 20 minutes of speaking with him he was still hesitant to exit, but did. He was safely arrested for elder abuse related charges, robbery, fraudulent use of access cards, violation of a court order, and resisting arrest. TPD also received information regarding a car meet which was to take place at Monte Vista Crossings at 7:30 PM. Officers were called in early to ensure public safety at this location. As a result the meet was moved to the 200 Block of N. Walnut where Officers continued their efforts.
