Another very hot day, and another very busy day for dayshift. The day started early with an officer witnessing a potential assault and battery. The officer spotted a male chasing another with a hammer. After the suspect was detained, the victim decided not to cooperate with the investigation. The suspect was eventually arrested for being drunk in public and since he was on parole, a parole hold was placed. Later in the day officers located a handgun that was listed as being stolen from a previous burglary. Officers also responded to a possible death. When they arrived, the suspected victim was not deceased, and with a faint pulse she was transported to a local hospital. Her husband was left alone and he displayed the onset of dementia. No family was available, and adult protective services could not assist. Eventually he was detained on a hold due to him not being able to care for himself.
