### SUPERVISOR COMMENTS

Officers responded to a call involving an assault & battery in-progress. When they arrived, it was determined that a male had trespassed into someone's residence and refused to leave. The home owner got into a wrestling match with the male and held him down until police arrived. The male was arrested for trespassing at the victim's request. Officers also responded to an assault & battery in-progress in a parking lot.
