# SUPERVISOR COMMENTS

Dayshift started out busy with a report of a disturbance between a male and female that came in at 0633 hours. Dayshift officers responded to the residence cutting their briefing short. They determined there was domestic violence between a male and female. The female reportedly was armed with a bat, broke vehicle windows and struck the male with the bat. She was arrested for assault with a deadly weapon and was booked into jail for it. He was wanted for shooting a firearm at a person by the Merced County Sheriff's Department. Officers located the suspect and his vehicle, detained him and waited for the agency to arrive and take custody of him. ## SUPERVISOR COMMENTS

Graveyard officers were proactive throughout the night. During one incident, an officer saw a male walking who was recognized as having a warrant. When the officer stopped the male to speak with him and confirm the warrant, the male took off running. The officer chased the male and got into a wrestling match with him in the middle of Geer Rd. The officer was able to overcome the resistance and place the male in handcuffs. during the struggle the male had thrown an unknown object into nearby bushes. The object was later found and determined to be fentanyl. The male was arrested and booked for additional charges outside of the warrant he had. Another officer contacted two people who were unlawfully camping. It was determined that one of them was restrained from the other with a no-contact order. He was arrested and taken to jail. An officer also contacted a male who was sitting on a public bench. After a brief conversation the officer checked the male for warrants. He was determined to have active warrants for his arrest and during a search he was found to be in possession of fentanyl and drug paraphernalia. The male had prior convictions for drug related charges so he was booked on a fresh felony, along with the warrants.
