This was our first day of our work week. Much like the last few weeks, it was busy once again. Officers started responding to numerous calls for service right after briefing. During

this shift, officers responded to a violation of a court order. A mother had a restraining order against her son, who always managed to flee prior to TPD arrival. He wasn't quick enough this time, and officers located him as he was leaving the area. He was arrested and taken to jail. Officers then responded to a traffic collision. While interviewing one of the involved drivers, they quickly determined he might be intoxicated. He was arrested as well. Later in the shift, a female called TPD reporting that she was being battered. When officers arrived, the caller became very uncooperative and would not give the officer much information. The officer determined that the caller was a victim of domestic violence abuse, but she would not confirm this. The investigation is still ongoing.
