SUPERVISOR COMMENTS

Saturday swing shift was less busy than the night before. That being said, when the day started to get dark we received several illegal firework calls. Officers attempted to locate the

violators but they were not able to locate them. Unfortunately, the reporting parties wanted to remain anonymous. During the shift officers contacted a subject that had an outstanding warrant. He was arrested without incident and taken to jail. Officers also responded to a suicidal subject who was telling his neighbors he wanted to apologize for any trouble he caused them, and then said he was going to kill himself. He was placed on a hold for his mental health crisis. During the shift, TPD had responded to a local motel for an issue that a female was having with her 15-yr. old child. He was being aggressive and threatened to assault her. When officers arrived, they spoke to all parties and decided to place the juvenile on a mental health hold. When the juvenile realized he was going to be placed on a hold, he became irate and uncooperative. He then decided to threaten the officers. During the struggle to detain the juvenile, he assaulted one of the officers by placing him in a choke hold. The officer did not sustain any injuries and the juvenile was detained. He was taken to juvenile hall for several felony charges.

SUPERVISOR COMMENTS

While on patrol, an officer saw a vehicle stop in the mid lanes of traffic with the hazard lights on. The officer contacted the driver and saw obvious signs of impairment. The driver was arrested for driving while under the influence of a narcotic and was taken to jail after a blood draw warrant was obtained. An officer contacted two occupants in a vehicle that was parked in a no parking zone. One of the males had three outstanding warrants and was arrested. While on patrol, an officer was flagged down by a motorist regarding an aggravated assault that was in-progress. A male had hit his girlfriend with a steel pole, and also hit a male family member who was trying to defend the female. When the officer tried to contact the suspect, he fled on foot. The officer chased him for a short distance and tackled him to the ground. The male was arrested for domestic battery, assault with a deadly weapon, and outstanding warrants. Another officer contacted a male who was trespassing at a 24-hour gas station and was refusing to leave. The male lied to the officer about his name, and after further investigation his true identity was discovered. He had an outstanding felony warrant and was arrested. Additionally, he was charged with provided a false name.
