The shift was steady all day between calls for service and self-initiated stops. An officer stopped a bicyclist and determined she was on searchable probation for stolen property. A male juvenile was arrested and cited. Another bicycle stop was made on a male who had a warrant for his arrest for narcotics charges. He was arrested. She suffers from dementia and walked away from the family's apartment. With the help of all available units, detectives, Cal state, and volunteers, we located her two hours later, and a couple miles away from the apartment in good condition.

An officer spotted a stolen vehicle being driven on the road. The vehicle was stolen out of Livingston and driver immediately pulled over before the officer could coordinate a stop. The driver was held at gunpoint until units arrived to assist. The driver was taken into custody and booked for possession of a stolen vehicle. Officers responded to an assault & battery involving domestic violence. The male suspect had slapped his girlfriend during an argument and left walking before police arrived. Officers located the male walking a few blocks away and he was taken into custody. Aside from the battery charge, he was also in possession of Meth and had warrants. He was taken to jail.
