2. **PUBLIC PARTICIPATION:**

Mayor Bublak announced that public participation would be heard in the discussion of the item.

3. **WORKSHOP**

- A. The City Council will review, discuss, and provide direction regarding implementation of the Community Priorities Advisory Committee (CPAC) Report.

City Manager Toby Wells introduced this item, provided an overview of the CPAC process and considerations, and invited CPAC Chair Jeffrey Lewis to present and discuss the report of the committee.

CPAC Chair Jeffrey Lewis provided an overview of the CPAC process and presented various details of the completed report submitted by the CPAC, including economic challenges facing the City, City employee health care and pension plans, resources and future stability of the Police Department, and a sales tax measure increase. CPAC Chair Lewis also provided information regarding highly recommended strategies, including the creation of a citizens advisory committee in coordination with the Police Department and changes to employee pension and healthcare benefits.

Council, staff, and CPAC members discussed this item, including public agency pension plans, sales tax measure proposal, impacts of COVID, CPAC committee member representation, and the growing demand, recruitment, staffing, and strategic planning/structure of the Fire and Police Departments.

*City Clerk Jennifer Land announced that members of the public will be given the opportunity to address Council concerning any item that has been described in the notice for this meeting. For those who are interested in addressing the Council, please press the “raise hand” feature on your screen or press *9 from your telephone keypad once the Mayor opens public comment and before she closes public comment.*

Members of the public will be allotted three (3) minutes for comments and will be taken in the order of which requests are received. When it is a member’s turn to speak, they will hear an automated prompt indicating their line has been unmuted – and that is when the three (3) minutes will begin.

Lastly, we request members who choose to address the Council to please state their first and last name in the event any follow up is needed; however, this is not mandatory.
