2. **ROADS PRESENTATION WORKSHOP:**

- A. The City Council will review, discuss, and provide comments to staff regarding the Preliminary Draft Pavement Management Program Report.

Roads Program Manager Fred Pezeshk advised council no action would be required other than their participation on the level of funding and duration of the CIP (Capital Improvement Plan). Mr. Pezeshk briefly discussed upcoming meetings that will be held for the public stating that there will be two meetings.

Representatives from Michael Baker International, Inc., Jim Porter and Dr. Ganji, provided a report and PowerPoint Presentation on the Draft Final Pavement Management Program Report. Via telephone Dr. Ganji provided an overview of the program and changes and reviewed the work completed.

He presented the findings and statistical data from the pavement management system analysis and pavement network statistics, provided a map highlighting the various conditions of city streets/areas, and discussed program options depending on funding availability. He presented information on pavement deterioration over time and the cost for repairs by providing the cost for different [PCI] scenarios and funding levels for both 5-year and 10-year CIP.
