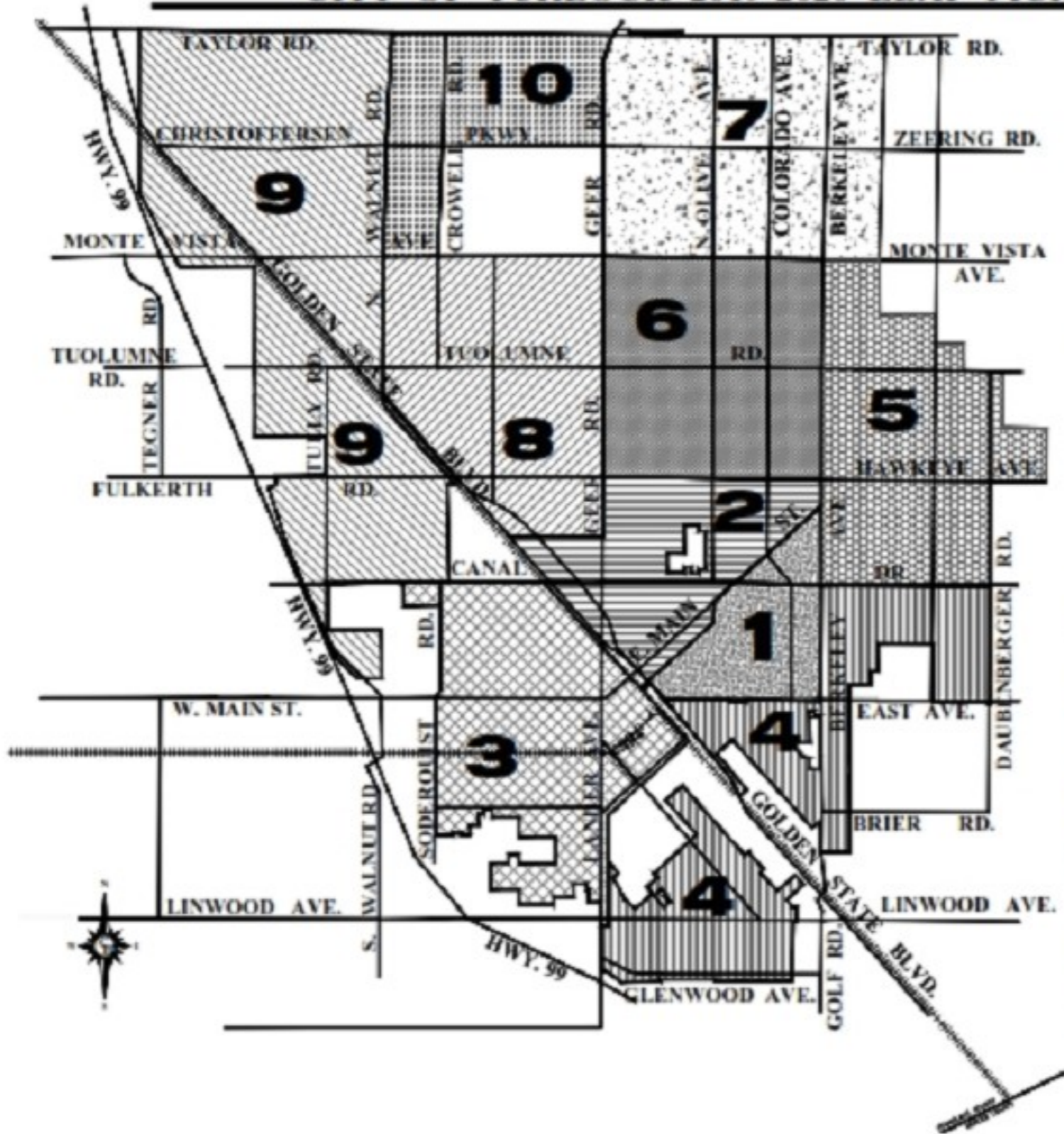

LEAF PICK - UP PROGRAM NOVEMBER 4, 2019 - FEBRUARY 7, 2020

The City of Turlock Parks, Recreation and Public Facilities Department will begin the annual Leaf Pickup Program on November 4, 2019. Turlock residents are encouraged to use their green waste containers for leaves and garden refuse. Any leaves that will not fit into the green container may be placed in the street 18" from the curbside in loose piles, not bagged. Limbs are not to be placed in leaf piles. **Do not park vehicles in front of your residence in locations which will prevent access to leaf collection the day prior to your scheduled day, on the scheduled day and the day after your scheduled day.** This will allow for more flexibility within the schedule.

The City is divided into 10 zones. Fridays are make-up days. Leaves are collected according to the schedule. 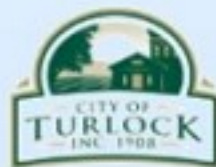

City of Turlock Has levels of 1,2,3-TCP Above Drinking Water Standards

Our water system recently failed a drinking water standard. Although this is not an emergency, as our customers, you have a right to know what you should do, what happened, and what we are doing to correct this situation.

We routinely monitor for the presence of drinking water contaminants. Testing results we received in August 2019 show our system exceeds the standard, or maximum contaminant level (MCL), for 1,2,3-trichloropropane (1,2,3-TCP). The standard for 1,2,3-TCP is 0.005 $\mu\text{g/L}$ (micrograms per liter) equivalent to 0.000005 mg/L (milligrams per liter). The average level of 1,2,3-TCP for the period of September 2018 – August 2019 for three out of the City of Turlock's eighteen drinking water wells was 0.0184 $\mu\text{g/L}$, ranging from less than 0.005 $\mu\text{g/L}$ to 0.0382 $\mu\text{g/L}$.

What should I do?

- You **do not** need to use an alternative (e.g. bottled) water supply.
- This is not an immediate risk. If it had been, you would have been notified immediately. However, *some people who drink water containing 1,2,3-trichloropropane in excess of the MCL over many years may have an increased risk of getting cancer.*
- If you have other health issues concerning the consumption of this water, you may wish to consult your doctor.

What happened? What was done?

On December 14, 2017 the State Water Resources Control Board's Division of Drinking Water established a MCL and monitoring frequencies for 1,2,3-TCP that went into effect January 2018. Due to the newly adopted MCL, the City of Turlock has three wells that have exceeded the allowable limits for the contaminant.

As a result, the City is required to increase monitoring frequencies for 1,2,3-TCP, develop a corrective action plan, and distribute a public notice to all drinking water customers every three months until the wells are no longer producing levels of 1,2,3-TCP above the MCL.

The City anticipates resolving the problem by June 30, 2021.

Please share this information with all the other people who drink this water, especially those who may not have received this notice directly (for example, people in apartments, nursing homes, schools, and businesses). You can do this by posting this public notice in a public place or distributing copies by hand or mail.

Secondary Notification Requirements

Upon receipt of notification from a person operating a public water system, the following notification must be given within 10 days [Health and Safety Code Section 116450(g)]:

- **SCHOOLS:** Must notify school employees, students, and parents (if the students are minors).
- **RESIDENTIAL RENTAL PROPERTY OWNERS OR MANAGERS** (including nursing homes and care facilities): Must notify tenants.
- **BUSINESS PROPERTY OWNERS, MANAGERS, OR OPERATORS:** Must notify employees of businesses located on the property.

This notice is being sent to you by the City of Turlock in compliance with the California Domestic Water Quality and Monitoring Regulations as a means of keeping the public informed.
